### WHAT DOES Naples Asset Management Company, LLC ("NAMCOA") DO WITH YOUR PERSONAL INFORMATION?

#### Why?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

#### What?

The types of personal information we collect, and share depend on the product or service you have with us. This information may include:

Social Security Number, Risk Tolerance Profile, Assets, Income, Account Balances, Account Transactions, Financial Objectives and/or Goals and other miscellaneous Personal Information

#### How?

All financial companies need to share customer personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customer personal information; the reasons NAMCOA chooses to share; and whether you can limit this sharing.

### How does NAMCOA protect my personal information?

### How does NAMCOA collect my personal information?

We collect your personal information, for example, when you

- seek advice
- enter into an agreement
- see management of portfolio assets
- provide identification
- provide account information

### Why can't I limit all sharing?

Federal law gives you the right to limit only

- sharing for affiliates' everyday business purposes—information about your creditworthiness
- affiliates from using your information to market to you
- sharing for nonaffiliates to market to you

State laws and individual companies may give you additional rights to limit sharing.

### What happens when I limit sharing for an account I hold jointly with someone else?

Your choices will apply to everyone who is part of your account

## Definitions

### Affiliates

These are Companies related by common ownership or control. They can be financial and nonfinancial companies.

### Nonaffiliates

Companies not related by common ownership or control. They can be financial and nonfinancial companies, such as account custodians:

### Joint marketing

This is a formal agreement between nonaffiliated financial companies that together market financial products or services to you. A joint marketing partners may include accounting firms, trust companies, insurance agencies and their agents. NAMCOA does not participate in Joint Marketing programs.
